We have three options through Cigna: two High Deductible Health Plans (HDHP) and one PPO plan. Choose the best fit for your family!



## HSA/FSA

Health Savings Accounts (HSA) are provided when partners elect a Medical HDHP plan. Truckstop contributions are prorated from your start date and are contributed per pay period.

Partners have the option to create a Flexible Spending Account (FSA) with pre-tax contributions for health care and dependent care.



## VISION & DENTAL INSURANCE

Through EYEMed we provide cost effective care for the whole family.

Our plan with Delta Dental has **no deductible!**



## TUITION REIMBURSEMENT
